

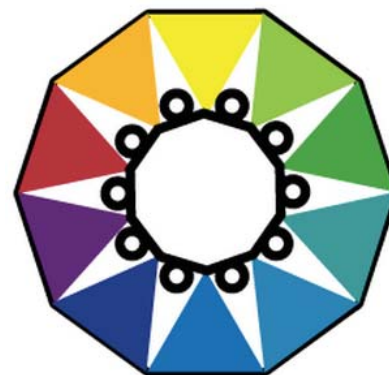

Funded by the Canadian Department of Foreign Affairs, Trade and Development (DFATD), the Tripartite Action for the Protection and Promotion of the Rights of Migrant Workers in the ASEAN Region ([ASEAN TRIANGLE Project: ATP](#)) is a five-year project that aims to promote and protect the rights of migrant workers. ATP works closely with ASEAN member states, ASEAN Secretariat, ASEAN Trade Union Council (ATUC), and ASEAN Confederation of Employers (AEC). The project promotes both bilateral and regional and tripartite approaches by engaging workers, employers and governments to make regionalism more effective and support the capacity building of institutions in ASEAN. The ASEAN Trade Union Council (ATUC) has developed

a complaint mechanism to document and track progress of migrant workers' complaints. The complaint mechanism comes with three standard forms – standard inquiry form, standard intake/complaint form, and standard case monitoring form. These forms are used by ATUC focal points on migrant labour to determine appropriate assistance to migrant workers in distress. A referral system ensures appropriate coordination with other national trade union centers in ASEAN, origin and destination countries, government agencies and partner civil society and non-government organizations.

The information collected from these forms will be entered into a web-based ATUC Information System on Migrant Workers database now under development. The database will produce meaningful analysis and reports to aid in design and implementation of interventions to improve systems for the resolution of migrant workers' complaints. This will strengthen ATUC and ATUC affiliates' data gathering on migrant workers, their inquiries and complaints, and monitoring the progress of resolution of these complaints. It will also provide evidence-based inputs into migrant worker advocacy and interventions.

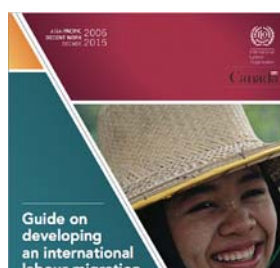
The International Labour Migration Statistics (ILMS) Database in ASEAN was successfully published on 18 December 2014 as a special collection on the ILO's central database, [ILOSTAT](#), as well as through the [APMigration](#) web-portal and [ASEANstats](#). The ILMS Database in ASEAN fills several important knowledge gaps for the region. For the very first time, it permits a comprehensive analysis of the existing labour migration trends within the region to help in the design and implementation of evidence-based policies. It maps out the scope and quality of the existing data sources in each country to highlight the ongoing knowledge gaps and to help better harmonise their definitions.

In order to strengthen and sustain the process of data collection and sharing in ASEAN, ILO held its Third Technical Meeting of Focal Specialists on International Labour Migration Statistics in ASEAN. The Meeting brought together Member States' experts responsible for collecting and analysing the data in each country alongside representatives from the ASEAN Secretariat, UN ESCAP and ILO. The meeting launched the third round of data collection, which will take place during July-August 2015 and will be published on ILOSTAT in September 2015. Participants agreed to a set of [recommendations](#) which included recommending the creation of an ASEAN Technical Working Group on Labour Migration Statistics.

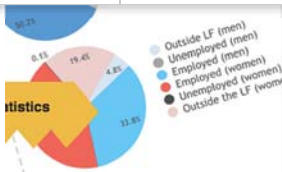

Cambodia, Lao PDR and Myanmar agree to take actions to develop a migrant welfare fund to protect their nationals abroad

May 26-27 2015, Vientiane, Lao PDR



In line with ASEAN TRIANGLE Project's work plan with Cambodia, Lao PDR and Myanmar (CLM), a workshop was convened to disseminate and validate the findings of a feasibility study and an operational blueprint that guide how CLM may establish migrant workers welfare fund programmes. The workshop was hosted by Lao PDR's Ministry of Labour, Employment and Social Security and attended by over 40 participants from CLM as well as high ranking officials from the labour ministries of the Philippines and Vietnam. The research team was led by former Philippine Labour Minister, Mr Marianito Roque, and composed of national consultants from CLM.

By the end of the event the participants agreed, where possible, to support measures that will lead to the establishment of MWFs or their equivalent in CLM. An Outcome Document that outlined key strategies and priority actions to do so was produced.

The Task Force on ASEAN Migrant Workers (TFAMW) organised a 2-day regional workshop to follow up on the Recommendations adopted at the 7th AFML held in Nay Pyi Taw, Myanmar on 20-21 November 2014. A total of 37 participants involved in this workshop from across the ASEAN member states examined the 20 recommendations from the [7th AFML](#).

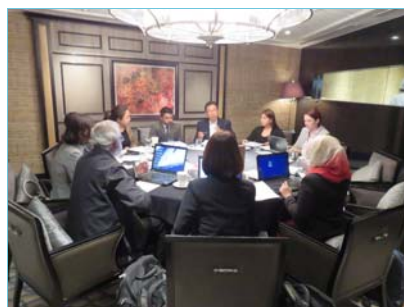
CSOs in the ASEAN agreed to implement the following 3 Recommendations:

- Recommendation no. 3 on providing inputs to assist ASEAN to develop framework/guidelines on standard employment contracts;
- Recommendation no. 8 on strengthening referral systems and complaints mechanisms;
- Recommendation no. 14 on engendering accessible information on national legislations, policies, rules and regulations on employment and labour migration issues to better inform migrant workers and all other stakeholders involved in the migration process.

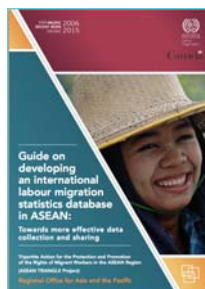
each ASEAN Member State.

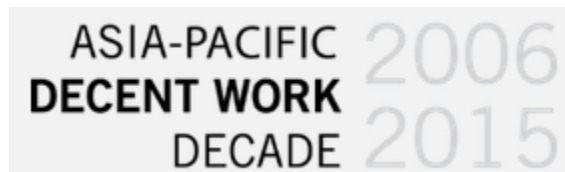
